The challenge we face every year is to **raise at least £300,000** in order to present the festival. Fundraising is unpredictable. From year to year, ENF's income can vary dramatically simply because one year we are more successful and luckier at competing for available funding than the next. To cover all the bills from ticket sales, every ticket would have to cost in the region of £70-£80 rather than £5-£25, so we are very, very grateful to the many loyal and generous supporters from the public and private sectors who support us.

By building an endowment we seek to allow ENF to do what it does, and do it so much better – to become more ambitious, plan with greater security, and make an even greater difference. An endowment will do that by reducing the risk of short-term funding unpredictability derailing long-term vision.
